Each person on the team tackles their projects and specialties, combining their various capabilities to ensure success for the team.

The team includes five project managers: Chris Martin, Aaron Wood, Steve Wasilefsky, Daoud Georgis, and Wayne Richter. Chris Martin handles outside projects, recently repairing a hot water piping servicing the west of campus with

minimized disruption to student residents. Aaron Wood tackles interior renovation and has recently constructed a more functional space for the Fishman Family Student-Athlete Enrichment Center. Steve Wasilefsky manages electrical engineering, and was responsible for the new Bull Runner bus maintenance and repair facility for Parking and Transportation Services. Daoud Georgis managed a complete roof replacement project over a portion of the USF Health medical school vivarium to protect animal research. Wayne Richter deals

in mechanical and building forensics, and investigated and corrected leaks in building envelopes (roof/walls) that caused damage to the interior of the Muma College of Business building.

Nicolas Fowler is a student assistant on the team and seeks any opportunities to learn from his colleagues. Sarah Baynard is the Assistant Director of Minor Projects and leads the team, specializing in funding and customer relations.

MLK Plaza

January 15th was Martin Luther King Jr day. A central component of USF's campus core is the MLK Plaza. The following article reflects on the history of the plaza's construction.

In 1993-94 there was to be an upcoming distribution of Student CITF funds for projects. At that time, the USF central Plaza was a vast, wide open space with little shade. There was a small bust of Dr. King on a low brick base near the Allen Building.



With the support of the USF President and the Vice President for Student Affairs in discussions with USF students for CITF funded projects, the Dr. Martin Luther King Jr. Plaza development project was proposed to create a more suitable tribute to Dr. King, as well as to create a variety inter-active event spaces and passive outdoor gathering places for students to use in the center of the campus.... to create a heart and soul for student life. The students approved the use of \$1.8M in CITF funds for the project.


The bust of Dr. Martin Luther King Jr. was recast by the original artist Linda Ackley and set at his true height with granite bands radiating out in the compass direction of five cities of major events in his life. The five bands slice through the landscape and

are inscribed with the name of the city at the end. The bust looks across the 140 foot fountain pool to a portion of the *I Have A Dream* speech inscribed in an inclined arched granite wall. The bridge through the eastern end of the pool provides for the heavily traveled student route from the Sciences/Engineering academic zone to the Student Center and housing district beyond. The design features also included shaded sidewalks along with table and benches.

The bust is located in the center of two trellis sections connecting the Allen Building with the Marshall Center plaza. For extra shade, the trellises are covered with bougainvillea for color and Jasmine for aroma. The trellis is bordered by rows of date palms. Just west of the trellis and bisected by the fountain pool are two areas with two rows of oak trees forming a square area of shade punctuated by a sunlit area in the center.



The bust of Dr. King faces an arched granite wall with a portion of the "I have a Dream" speech inscribed in it. A 140 foot fountain pool sits between the bust and the granite wall.

Against the back wall of the Student Services building (SVC) is a sunken plaza with seat walls for events, including an elevated section of sidewalk that can be used as a stage with power provided. This area formerly included water fountain jets in the pavement but they have been removed. Crepe myrtle trees were also planted between the SVC and the trellis for shade. There is also a quiet sunken garden on the southeast corner of the plaza.

From programming through construction USF students were actively involved in the process. There were communications with the King family regarding the dedication and the use of the *I Have A Dream* speech. The design consultant was Sasaki and Associates, the architect was Reynolds Smith and Hills, and the contractor who built it was Saul Rentz of S&L Construction, a minority firm. The ground breaking occurred in January of 1996 and the Dedication was held in November of 1996, just 10 months later.

Since the completion 1996, the plaza has been extended westward with many more shade trees planted along the sidewalks that traverse it, places to sit in the shade, and two additional shade trellises. The Phyllis Marshall Student Center and USF

Bookstore were built on the north side with the Running Bulls plaza connecting to the MLK Plaza.

The Dr. Martin Luther King Jr. Plaza areas have been used by the USF students for a great variety of events over the years and will continue long into the future, creating memories of their student life at USF.


