TEACHING EXPERIENCE

I have taught more than 20 different courses in philosophy and humanities and cultural studies, ranging from introductory-level lecture courses designed for first-year college students to graduate seminars for Ph.D. students. I have worked with individual students on directed readings on many, diverse topics, united by my interests in feminism, philosophy, ethics, and humanities. Topics include filmic representations of *Little Women*; early American female captivity narratives; feminist interpretation of representations of mermaids in American culture; the philosophical analysis of trust; ethics and special obligations; and early modern moral philosophy, to name a few.

MENTORSHIP OF STUDENTS

I have worked actively as a mentor to many students, both undergraduate and graduate. I have directed two Ph.D. students in Philosophy; six MA students in Humanities, American Studies, Film Studies, and Social and Political Thought; and seven undergraduate honors theses in Philosophy. I have served on an additional ten Ph.D. committees in Philosophy and English, and on an additional 13 MA committees in Humanities, Philosophy, and Religious Studies.

I have successfully sponsored several undergraduate students for nationally competitive programs, including one who attended the Diversity Program in Logic at the University of Massachusetts; two who attended the Rutgers University Summer Institute for Diversity in Philosophy; and three who attended the Philosophy in an Inclusive Key Summer Institute at Pennsylvania State University.
