Dr. Tameca Jewell Beckett – Statement of Interest

Please accept this statement of interest as earnest consideration for the position of Assistant Professor of Instruction – School of Information. I meet all qualifications --- experience in librarianship, technological innovation in planning and implementation, administrative oversight, instructional leadership and coalition-building experience.

My enthusiasm, interest and confidence in my capability in this position stems from a wealth of professional knowledge and experience as a librarian, educator, technologist and researcher, and my administrative experience directing and transforming libraries with stellar collaborative, planning, negotiation and analytical skills.

The fundamental marker of my teaching philosophy is framed around the question, 'To whom does this learning belong?' One may suggest that the answer is the students, of course, but I would counter, on what level? And to further investigate, my follow-up questions are; How does this syllabus, these resources, and this course create an authentic learning experience?; What about these assignments electrify and support engagement with the material?; Where, in my teaching, planning and practice, do I intentionally and unequivocally reflect and foster intersectionality, equity, diversity and inclusivity? A more accurate answer to this question is that learning belongs to us all at different levels, stages, and points of need; instructors, students, the community of learners, and society.

I believe I have a responsibility to create a learning experience that is thoughtful, responsive and advocates for critical and reflexive analysis built on the framework of equity, diversity and inclusion. This learning belongs to me. As an instructor, I am the first learner. As a conductor for an orchestra, I listen to how a particular passage can harmonize with a writing assignment. I hear to learn whose voices are missing and why. I reflect on my feeling and reaction to the material to examine my bias or conflict. This iterative, student-centered process continues until I hear a harmony that can elevate the learning experience. Then I listen to this orchestra and learn every note, every section and every break, with the full knowledge that as each student picks up these instruments and devices that I have selected, new melodies, harmonies and sounds will be created, as they should.

I believe in creating an environment of critical thought, self-reflection, and high expectations for academic success. This learning belongs to the students on an individual level. As an educator, my goal is not to stand in front of students and impress them with my expertise but to co-create an environment that allows for individual reflection and critical thought. For example, I incorporate reflection to enable the students to connect with the readings and theory, not only from their unique background and lived experience but also from a critical lens, allowing them to see themselves as a part of the scholarly conversation. I try to help students move toward metacognition and synthesis of material by including assignments that reflect on the material and their reflective learning process in my assessment plan. I model listening and lifelong learning throughout the course by positioning myself as a co-learner and encouraging students to move beyond simply learning facts and concrete skills to developing critical consciousness and deep reflection as they engage in the learning process.

I believe all learners deserve to be valued, treated with dignity and respect, and have their voices heard with openness, empathy and compassion. This learning belongs to the community of learners. As a new group of learners comes together to create a learning community, I start by engaging exercises that allow the newly formed group to get to know each other and build trust. In particular, we discuss the importance

of creating a safe and welcoming environment where all voices are valued and respected. I use in-class group exercises to encourage discussion and even difficult conversations, using our co-created tools and guidelines to ensure learners feel comfortable and safe contributing to the group dialogue. Likewise, I use project-based group assignments to allow learners to facilitate, organize, resolve conflicts, communicate, teach, and learn from each other.

I believe that learning is a cooperative endeavor that can be transformative to the learner and impact in the community. This learning belongs to society. Throughout the course, I frame the materials, assignments and conversation within the larger context of the societal and global implications. In their reflective practice, learners are encouraged to consider and restructure this knowledge for future application. Through individual and group action research, learners engage with real-world issues to further develop their critical thinking, problem-solving, and collaborative skillset. Taking the learning out of the classroom and into the community allows learners to use creativity and reflection while working through intellectually challenging issues that highlight the divergence and convergence of theory and practice.

I believe that I have a responsibility to serve my community and contribute practically and intellectually to my profession. I have remained actively involved in education on a local, state, national and international level throughout my career. My intentional proximity to diverse communities and issues has given me a well-rounded lens that informs my educational approach and service. For example, my work on the Board of Directors for the Association of Rural and Small Libraries and projects with the Lubuto Libraries and the Bryan Allen Stevenson School of Excellence has had a tremendous impact on all aspects of my life as an educator, community leader, and researcher.

We, the library and information science profession and representative libraries, find ourselves at an important moment within the arc of the information universe where traditional paradigms are not only unsustainable but actively work against the very essence of scholarly knowledge creation and production. This has a direct impact, not only in advancing scholarship but on society at large. Libraries, our resources, collections and services, are for the public good. I am interested in this position because as we stand at a time of opportunity in the history of libraries, we are responsible for equipping future professionals with the skills needed to address challenges within our global society.

Our next steps will open the doors of innovation and research, and provide access to information that scholars, teachers, leaders, students and society will use to educate, advance, create, dismantle and preserve. It is our responsibility and our charge in this time to move forward strategically and collaboratively to seek creative avenues while fundamentally retaining the integrity of our stewardship, principles and values. I believe that what we do now is the future, and the bridges that we build and redirect will lead the way to exponential growth in knowledge creation, production and dissemination. I am committed to use my wealth of experience, scholastic acumen, innovative and collaborative leadership to take up this charge.

As an educator, instructional leader and scholar-practitioner, I am committed to creating a learning environment that is reflective, inclusive and sets high expectations for all learners. I am enthusiastic about active, inquiry-based learning that is collaborative, engaging and focused on student achievement. I aim to co-create spaces with scholars to approach and understand issues to conceptualize and develop creative, data-driven, and holistic solutions. As a scholarly writer, researcher and educator, I am aware of the concerns of the academic community as they seek to place their contribution to scholarship into publication and practice. As a digitally astute librarian, I am aware of the dire need for innovative and strategic approaches consistent with the overarching rights and principles that have guided and upheld the profession. This framework and lens of experience, coupled with my innovative approach to development, information and libraries, qualify me for this position.

The opportunity before us will require the knowledge and experience of a dynamic, collaborative and reflective leader, and I am ready and capable.

Throughout my career, I have come to appreciate my time living with and serving diverse communities from Zambia, to Guatemala to rural areas in the United States. The interconnectedness of libraries and the people that they serve have influenced my servant-visionary leadership style. It is my firm belief that libraries are not just about books and resources, but foundationally about people. Being a visionary leader allows me to move beyond 'thinking outside the box' to a mindset where the boxes that confine us and serve as a barrier to reaching our greatest potential, simply do not exist.

As an ALA Emerging Leader, ALA elected Councilor representing Delaware, and an Institution of Museum and Library Services Rare Book School Fellow, I have embraced the opportunities afforded me in this great profession. My experience of being an architect for engagement and catalyst for dialogue within organizations has led to gains from technological, administrative, and organizational levels. The innovative and strategic leadership that I provide is engaging, fiscally responsible and focused on our future capabilities to continue upholding the principles and values central to librarianship while embracing new bold ideas and actions.
