LEBEL v. ROE et al.: Major Charter of Rights and Freedoms challenge to the constitutionality of the Yukon Mental Health Act, plus allegations of violation of the plaintiff's constitutional rights, false imprisonment and assault charges. The case against the five defendants was heard in Yukon Supreme Court, Whitehorse, December, 1993. Final argument was heard January 4 and 5, 1994. Claims of false imprisonment and breach of § 7 Charter of Rights and Freedoms were successful against one of the defendants. Lebel v. Roe et al. Supreme Court of Yukon Territory (unreported), S.C. ISAAC v. WORKERS' COMPENSATION BOARD: Action on behalf of a widowed first nation's woman and her four children who were denied compensation for the workplace death of her husband and their father. Involving constitutional issues of the division of power between the provincial and federal governments, the Indian Act, and discrimination on the grounds of race; it was heard by the B.C. Court of Appeal in May, 1994. Appeal allowed for benefits, unsuccessful on Charter issues. Isaac v. Workers' Compensation Board (1994), 93 B.C.L.R. (2d) 273 (C.A.); Isaac v. British Columbia Workers' Compensation Board (1994), 9 W.W.R. 245 (B.C.C.A.)

CONSTITUTIONAL CHALLENGE TO NAFTA: On behalf of Action Canada Network, B.C. we completed a brief outlining the legal basis for challenging the North American Free Trade Agreement. In Fall, 1993 the provincial government of Ontario announced they would challenge NAFTA through a reference case to the Ontario court of Appeal. The basis of a challenge would be the constitutional division of power in the *Constitution Act*, 1867. However, our clients decided against legal action.

WEST KOOTENAY POWER LTD. HEARINGS: Acting on behalf of Consumers' Association of Canada (B.C. Branch), B.C. Old Age Pensioners' Organization, Council of Senior Citizens' Organizations of B.C., Federated Anti-Poverty Groups of B.C., and Senior Citizens' Association of B.C. regarding Revenue Requirements, Rate Design and Integrated Resource Planning. Rossland, B.C., March, 1994 and spring, 1996, before the British Columbia Utilities Commission. This entailed alternative dispute resolution mechanisms (ADR).

KEMP ET AL. v. CRIMINAL INJURY COMPENSATION BOARD: Representing parents of murdered children, and adult children of murdered parents who were denied compensation because they are not "victims of crime", according to the Board's interpretation of the Criminal Injuries Act. The case concerns institutional degradation and systemic discrimination against the victims of crime. The appeal provided an opportunity to break new ground concerning the definition of "victim of crime" and address the concerns of those who have family members murdered. The case was precedent-setting due to the fact that the Appeals Commissioner established a public review process concerning the issue and heard several cases together regarding this issue. The appeals Panel denied compensation so we filed a petition for judicial review in the Supreme Court of British Columbia. One month before the court hearing the provincial government announced changes to the Criminal Injuries Compensation Act to include family members of murder victims as victims of crime for the purposes of the Act. The changes became law in fall, 1995 and reflected the efforts of our office and victims groups to put

pressure on policymakers. In the spring of 1996 we were handling the resubmission of the cases under the new legislation.

JACKSON v. WORKERS' COMPENSATION BOARD, APPEAL DIVISION: Ms. Jackson was a client of PIAC several years ago. While driving taxis she was the victim of a brutal rape and we helped her get a 100% disability pension from the Workers' Compensation Board. She suffers post-traumatic stress and her dealings with the Board, including the monthly cheque, contribute to the problem. We appealed a decision not to give her total commutation of her pension. The case concerned significant issues of policy regarding women, pensions and sexual assault and the Workers' Compensation Board. A decision of the Board rendered April 27, 1995 allowed, in part, the appeal. The client received one year commutation, after which they will consider further commutation.

ADBUSTERS MEDIA FOUNDATION v.CANADIAN BROADCASTING CORPORATION: The Media Foundation, in co-operation with Greenpeace, produced an environmental advertisement – Autosaurus. CBC agreed to run the advertisement during its program "Drivers' Seat". After it was aired once, CBC notified Media Foundation that the advertisement violates the Advocacy Advertising Standards and could not be run again as agreed to in the contract. The case involves breach of contract, and a challenge to the actions of CBC and the Advocacy Standards as violating the Canadian Charter of Rights and Freedoms, s. 2(b) (freedom of expression) and s. 15 (equality before and under the law). The trial was heard October 23-25, 1995 in the Supreme Court of British Columbia. On November 8, 1995 Mr. Justice Holmes issued his Reasons however, he found that the Canadian Charter of Rights and Freedoms does not apply to the CBC. Adbusters Media Foundation v. Canadian Broadcasting Corp. (1995), 13 B.C.L.R. 3rd 265 (S.C.).
