This curriculum fits into a multi-tiered system of support with a focus on children with limited oral language skills. The Story Friends curriculum embeds vocabulary and comprehension instruction within carefully constructed books designed for preschoolers. Through an iterative development process, this project capitalizes on a skilled and experienced research team to produce feasibility results and promising pilot data that will provide a strong basis for a subsequent large-scale efficacy study of

the Story Friends curriculum. The long-term goal of this project is to reduce preventable reading disabilities by improving oral language skills of preschool children.

Description: This partnership conducts research that identifies factors and resources that are likely to result in improvements in the implementation of a model of Multi-Tiered System of Supports (MTSS) in Early Childhood Learning settings in the district. This MTSS model seeks to enhance children's school readiness and create a seamless transition between Pre-K and Kindergarten.

### **Transitions to Family Care Giving and the Impact on Health Indicators**

Description: This project examines the psychological, social, and health consequences of becoming a family caregiver for a relative with chronic illness. Participants in a large population based study, who had not been caring for a relative at baseline, complete telephone screening to ascertain whether they have taken on caregiving responsibilities since the baseline assessment. Pre caregiving measures of their health, psychological functioning, healthcare utilization, and daily functioning are compared to post caregiving measures. In addition, a control sample of individuals who have not become caregivers complete similar measures. Results will be among the first to document the impact of caregiving stress on diverse outcomes using a population based sample, and prospective methods.
