Global and National Security Institute Appoints Larry Handen to its Board of Advisors

Global investment leader with over three decades experience in the fields of technology, government, and professional services.

TAMPA, FLORIDA, August 29, 2023 – The Global and National Security Institute (GNSI) at the University of South Florida (USF) has named global investment leader Larry Handen as the newest member of its Board of Advisors.

Handen is a Senior Managing Director and Global Head of Macquarie Capital's Growth and Technology group, which specializes in growth investments and buyouts. Macquarie Capital is a division of Macquarie Group, a global financial services firm operating in 34 markets in asset management, retail and business banking, wealth management, leasing and asset financing, market access, commodity trading, renewables development, specialist advisory, capital raising and principal investment. In his career, Handen has served on the Board of Directors of more than 50 companies worldwide and he believes this appointment to GNSI's board could have global effect.

"GNSI plays an important role in researching, analyzing and formulating policies around a highly diversified set of security threats globally," Handen explained. "Unlike single-issue institutes, GNSI's agenda and extensive resources will allow it to be an independent and effective resource for identifying, evaluating, and formulating solutions to an ever-changing threat landscape. I appreciate the chance to support General McKenzie and the GNSI team as they undertake this important effort."

During his career, Handen has been a principal investor in more than 175 transactions and has advised over 100 companies in various capacities.

GNSI Executive Director, General (Ret) Frank McKenzie, believes Handen's global experience will play a key role in guiding the Institute into a larger, higher-profile role in the global and national security environment. GNSI was created by USF in June 2022.

"GNSI has taken some great strides in these first fourteen months," McKenzie said. "The opportunity in front of us is even greater than we anticipated. Larry will be an important voice in developing and



refining our strategic direction. He's already shown to be a tremendous advocate for GNSI and believes in our mission and vision."

Prior to his role at Macquarie, Handen was a Managing Director at Insight Venture Partners. Before that, Handen was a General Partner at UBS Capital where he led the firm's Technology Group. He also played a key leadership role as a Partner with PricewaterhouseCoopers Consulting, leading a practice specializing in corporate-wide growth and recovery solutions for companies in the technology, information, communications, and entertainment industries.

Handen received a BA in Economics and Political Science from Bucknell University and an MBA from NYU's Stern School of Business
