## SEPTEMBER 9, 2019 - REPORT

- 1. Dr. Bahner welcomed everyone and had Introductions.
- 2. There was no public comment on agenda Items.
- 3. Dr. Bahner and Dr. Bahr reviewed the process for new members
- 4. Dr. Bahr reviewed the policies needing discussion and explained the issue with each. She noted that the Graduate Faculty issue will take more time to do since so many areas are impacted by the policy. The other policies are a bit easier to update, so the focus will be on them over the next few meetings.
  - **<u>Graduate Faculty</u>** requested to revisit the policy for Graduate Faculty Definition and Affiliate Graduate Faculty definition.
  - o <u>Academic Dismissal</u> need to update language to include situations of professional misconduct.
  - English Proficiency Score options updated by Admissions for the 2019-20 Catalog this is just noted for the record
  - <u>Grad Enrollment</u> need to update policy to encourage students to graduate on time. Ref 10-505 as a resource
  - o **<u>Reinstatement</u>** need to clarify when Time Limit Extension is needed
  - <u>Repeating a course</u> need to specify parameters for how many times and which courses a student can repeat? (e.g. not allowing ability to repeat a non-repeatable course that a student received an "A" in to boost the GPA; also noted that sequence issues can impact this as well)
- 5. Old Business
  - o **Doctoral Projects** need to add language to address Doctoral Projects.

- <u>Graduate Certificates</u> need to add language to define core (2 graduate courses) and that they should tie into a major. Consider language that limits how long a Certificate may be active if it is no longer having students complete the certificate within the five-year timeframe.

Applicants whose native language is not English must demonstrate proficiency in English by submitting acceptable scores on one of the English proficiency tests listed below. Scores must have been earned within two (2) years of the desired term of entry. Applications submitted with English proficiency scores that do not meet the minimum requirements will be denied.

Note – the following test scores are for the purposes of Admissions and do not demonstrate English Proficiency for Teaching Assistant (TA) positions.
