**Alternate Medical Insurance Policies List**

The insurance companies listed offer individual policies that meet the minimum requirements, as stipulated in both the **SUS Florida Board of Governor's Regulation 6.009(6)** and **USF Regulation 6.0162** health insurance mandates for international students.

It is the University of South Florida (USF) student's responsibility:

1. To select a medical insurance policy that meets/exceeds the **SUS Florida Board of Governor's Regulation 6.009(6)** and **USF Regulation 6.0162** for the full academic year (365 days)
  - a. Students issued **F-1 or J-1** visa's continuous coverage must be in effect until **August 10, 2022 or later**, regardless of graduation dates and/or leaving the country for a break. New student's effective date should be **August 23, 2021 or prior**.
2. To review the 'Exclusions and Limitations' section of the policy under consideration.
3. To advise the insurance company that they are attending the University of South Florida.
4. To provide their issued visa information in some instances their passport number.

**Please submit coverage information no later than August 20, 2021.**
