

Alternate Medical Insurance Plans for USF International Students

FOR INFORMATIONAL PURPOSES ONLY – 2016-2017 Academic Year

- 1) USF does **NOT** endorse or sponsor any of the companies below. This is a list of insurance companies in alphabetical order that offer individual policies which meet the minimum requirements.
- 2) It is the student's responsibility to find a medical insurance policy that meets the State of Florida *and* University of South Florida insurance mandate. Students should look at Exclusions and Limitation to ensure they are purchasing a policy that meets all their health care needs.
- 3) Students should advise insurance company that you are attending the University of South Florida and the visa you are currently carrying. Some companies may require your passport number.
- 4) [USF Regulation 6.0162](#) requires adequate insurance for the full academic year. Students carrying an F or J visa should have coverage until August 9, 2017 even if you are planning to graduate and/or leave the country.

Once you purchase an alternative policy, the insurance company will submit proof of your policy to our office. If your policy is approved, the insurance fee will be removed from your Oasis account. If your policy cannot be approved, an email will be sent to your USF address. Please allow 48 business hours for us to receive proof of your alternative insurance policy from one of the companies below. Allow up to 3 weeks for review of your alternative insurance policy.

Our office reserves the right to refuse documents received after December 16, 2016. We have the right to verify coverage and/or eligibility at any point throughout the academic year.
