# DISCOVER

## Funding:

Allowance to cover cost of living, travel, and family. Grant is awarded to host organization; research costs and overhead of host organization are also supported.

*There are two types of Individual Fellowships:*

### 1. European Fellowships:

- Duration: 1-2 years
- Held in the EU or associated countries.
- Open to researchers either coming to Europe or moving within Europe.
- Can help to restart research careers after a break such as parental leave.
- Can also help reintegrate researchers coming back to Europe.
- Can also include a period of 3-6 months in another organization in Europe that would boost the impact of this fellowship.

### 2. Global Fellowships:

- Duration: 2-3 years
- Fund a researcher from the EU or an associated country to travel to USF for collaboration.

## Programs of Interest:

All research areas can be funded except those covered by the EURATOM Treaty.

## Deadline:

Early September 2017.

## MARIE SKŁODOWSKA-CURIE ACTIONS

**Individual Fellowships** provide support for experienced researchers undertaking mobility between countries with the option of working outside of academia. **There are two types of Individual Fellowships: European and Global.** Applicants must have doctoral degree or at least four years of full-time research experience by the time of the call deadline. All research areas can be funded, except those covered by the EURATOM Treaty, as referred to in Article 4 and Annex I.

Mobility across borders is a must, and cross-sectional mobility is also encouraged. The grant provides an allowance to cover your living, travel and family costs. The grant is awarded to your host organization, usually a university, research center, or a company in Europe. The research costs and overheads of the host organization(s) are also supported. Program is made available via Horizon 2020 under the Main Pillar of Excellent Science.

## COLLABORATIVE RESEARCH TRAVEL GRANTS

The Collaborative Research Travel Grant (CRTG) program provides up to \$15,000 in support for relatively unrestricted travel funds to academic scientists (faculty and postdocs) at U.S. or Canadian degree-granting institutions. Grants must be used for domestic or international travel to another lab to learn new research techniques or begin or continue a collaboration to address biomedical questions. All proposals must be cross-disciplinary. Applicants with a doctoral degree in the physical, mathematical, or engineering sciences working on a biological problem are encouraged to apply. Conversely, proposals from biological scientists who desire to collaborate with a physical scientist, mathematician, or engineer are also encouraged to apply.

Applicants must hold a PhD in mathematics, physics, chemistry, computer science, statistics, or engineering at the time of application and interested in investigating research opportunities in the biological sciences are eligible. Biologists holding a doctorate degree at the time of application who are interested in working with physical scientists, mathematicians, engineers, chemists, statisticians, or computer scientists to incorporate their ideas and approaches to answering biological questions are eligible to apply.

Only proposals addressing questions in the biomedical sciences will be accepted. All proposals must be cross-disciplinary.

## ASPPH/CDC ALLAN ROSENFELD GLOBAL HEALTH FELLOWSHIP PROGRAM

The Allan Rosenfield Global Health Fellowship Program provides training opportunities in global public health for recent graduates of ASPPH member CEPH-accredited schools and programs of public health (MPH and Doctoral level). The fellowship is a training opportunity to learn from leading global health experts in CDC headquarters in Atlanta as well as various international posts. Fellows will benefit from an opportunity to apply and translate academic knowledge of public health to real world situations. Global health fellowships may be placed within a global health program at CDC headquarters in Atlanta, GA or in one of the 50 foreign countries where CDC is working with the Ministry of Health and other public health partners. Additional travel during the fellowship period may be required depending on program activities. Exact geographical locations will not be determined until the final placement process. At that time, successful applicants will be offered positions and notified of the geographic location for that particular position. The selected fellows will be required to relocate to the fellowship assignment locations.

**Eligibility:** applicants must have received their Master's or Doctorate degree prior to the beginning of the fellowship (no later than August 2016) or within the last five years (no earlier than May 2011). Graduate degrees must come from an ASPPH member graduate school or program of public health accredited by the Council on Education for Public Health (CEPH) <http://www.aspph.org/member-directory/>. All applicants must be U.S. citizens or hold a visa permitting permanent residence ("Green Card") in the U.S. to be eligible for the fellowship program. # SOCIAL POLICY



## National and International PhD Candidates

Horowitz Foundation for Social Policy offers support to emerging scholars through small grants in order to promote scholarship with a social policy application, and to encourage projects that address contemporary issues in the social sciences. Grants are based solely on merit. Each grant is worth a total of \$7,500.

The first installment of \$5,000 is paid upfront to the grant recipient. For grant recipients to be entitled to their second installment of \$2,500, they must show evidence of one of the following:

- Acceptance and approval of their dissertation
- Acceptance of an article based on the research by a peer-reviewed journal
- Invitation to write a book chapter based on the research

Grants are non-renewable and recipients have 5 years from announcement of the award to complete their project and claim their final payment. Only current PhD candidates who are working on their dissertation are eligible; those who have completed their PhD are ineligible. Applicants must have defended their dissertation proposal or their topic approved to apply.

The Foundation accepts applicants from any country and any university in the world. U.S. citizenship or residency is not required. The foundation targets projects with a social policy application on a global or local level.

Applications are evaluated based on the Trustees' assessment of criteria such as: feasibility, applicability, originality, methodology, theoretically informed or empirically rich research and letters of recommendation. No specific weight is given to any one area. Proposals are evaluated based on overall merit of all aspects of the application. Awards are made to individuals, not institutions. If processed through an institution, a waiver for overhead is required.

Recipients are expected to acknowledge assistance provided by the Foundation in any publication resulting from their research and are also asked to notify the Foundation with publication details.

Grants are issued immediately on receipt of an acceptance letter from the recipient. It is the applicant's responsibility to ensure the grant does not conflict with other funding they have secured.

The Council of American Overseas Research Centers (CAORC) is a private nonprofit federation of independent overseas research centers (ORCs) that promote advanced research, particularly in the humanities and social sciences, with a focus on the conservation and recording of cultural heritage and the understanding and interpretation of modern societies. CAORC fosters research projects across national boundaries, encourages collaborative research and programmatic and administrative coherence among member centers, and works to expand their resource base and service capacity.

CAORC member centers maintain a permanent presence in the host countries where they operate—in Europe, Latin America, the Near and Middle East, South and Southeast Asia, and West Africa. The centers are the primary vehicle through which American scholars carry out research vital to our understanding of and intersection with other cultures. Nearly 400 American universities, colleges, and museums hold memberships in the centers which serve their institutional members, individual fellows and members, and affiliated scholars through a broad range of research- and teaching-support services. Funding is awarded from sources including the U.S. Department of State, the U.S. Department of Education, and the Smithsonian Institution; private foundations and individuals.

Research centers promote international scholarly exchange, primarily through sponsorship of fellowship programs, foreign language study, and collaborative research projects. They facilitate access to research resources, provide a forum for contact and exchange, offer library and technical support and accommodation, and disseminate information to the scholarly and general public through conferences, seminars, exhibitions, and publications. Because of the centers' contributions to the generation of knowledge, the creation of area expertise, and cordial relations between the United States and the host countries, scholars seek CAORC's help in establishing similar centers in other parts of the world.

## MULTI-COUNTRY RESEARCH FELLOWSHIP

The Multi-Country Research Fellowship supports advanced regional or trans-regional research in the humanities, social sciences, or allied natural sciences for U.S. doctoral candidates, and postdoctoral scholars. Preference will be given to candidates examining comparative and/or cross-regional research. Applicants are eligible to apply as individuals or in teams. Scholars must carry out research in two or more countries outside the United States, at least one of which hosts a participating American overseas research center.

**Project Description:** In 1500 words or less, please describe the nature of the proposed project and the scholar's competence to carry out the required research.

**Project Bibliography/Literature Review:** Submit a one-page bibliography or literature review outlining project resources.

**Letters of Recommendation:** Two (2) letters of recommendation. PhD candidates must have one letter from an Academic Advisor with a signed Academic Advisor form.

**Curriculum Vitae:** Three (3) pages maximum. Additional pages will not be submitted to the review committee. Please ensure that prior awards and language capacity are clearly noted.

**Transcripts:** PhD candidates only. Please submit transcripts from your most recent institution.

In addition, research that embraces a humanistic approach and methods will be considered.

**Applicants must propose four consecutive months of research in an American Overseas Research Center in one of the following countries:** Algeria, Armenia, Azerbaijan, Bangladesh, Cambodia, Cyprus, Georgia, Indonesia, Mexico, Mongolia, Morocco, Nepal, Senegal, Sri Lanka or Tunisia.

Selected fellows must work on their research full-time during their period of funding. ## NATIONAL ENDOWMENT FOR THE HUMANITIES RESEARCH FELLOWSHIPS AT ACOR

The American Center of Oriental Research (ACOR) offers one to two awards of four to six months for Postdoctoral scholars at the institute in Amman through the National Endowment for the Humanities (NEH). The fellowship supports research in the humanities and disciplines of the social sciences that have humanistic content and employ humanistic methods. Fields of research include modern and classical languages, linguistics, literature, history, jurisprudence, philosophy, archaeology, comparative religion, ethics, and the history, criticism, and theory of the arts. Social and political scientists are encouraged to apply.

Research topics should contribute to scholarship in Near Eastern studies. This program does not support work in the creative or performing arts, research undertaken in pursuit of an academic degree, the preparation of textbooks, projects that focus on pedagogical theory, research in educational methods and practice, or cognitive psychology. Nor does the program support projects that are directed at persuading an audience to a certain political, philosophical, religious, or ideological point of view, projects that advocate a particular program of social action or change, or projects that examine controversial issues without taking into account competing perspectives. Applicants should have a PhD degree or equivalent professional training at the time of application. They must be U.S. citizens or have lived in the United States for the three years immediately preceding the application deadline. Awards cover transportation by a U.S. carrier, accommodation and research facilities at ACOR, and a monthly stipend.

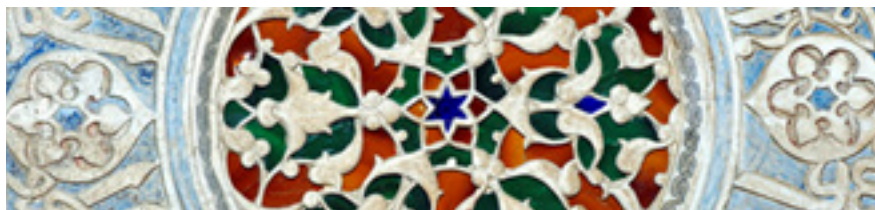

## AMERICAN RESEARCH CENTER IN EGYPT (ARCE)

Over the course of six decades, ARCE's fellowship program has benefited more than 700 scholars, whose research interests span the diversity of Egypt's periods and cultures. Program alumni include directors and faculty of Middle Eastern studies and history departments at leading universities in the United States and abroad, and curators of Egyptian and Near Eastern art at major museums and research institutions. Collectively, the publications resulting from ARCE fellowships constitute a substantial collection of all scholarly output on Egypt by Americans since 1957.

Decades of close collaboration with the Egyptian Ministry of Antiquities (MoA) and Ministry of Higher Education (MoHE) enables ARCE to provide fellows with solid administrative support and advice that eases access to Egyptian museums, monuments, archaeological sites, and research libraries, archives and Egyptian academia.

**ARCE Fellowships**

Available to American pre-doctoral candidates (ABD), postdoctoral scholars, faculty and senior scholars at universities worldwide for a minimum stay of three months and maximum stay of 12 months. U.S. citizenship is required.

**National Endowment for the Humanities**

Available to American postdoctoral scholars, faculty and senior scholars worldwide with a minimum stay of four months and maximum stay of 10 months. NEH funds may be awarded to foreign nationals who have been residents of the United States for three consecutive years immediately preceding the application deadline. Minimum stay is four months; maximum stay is 10 months.

Applicants who possess a doctoral degree by October 1, 2017 will automatically be considered for both the Fellowship and NEH funding.

**Several other funding opportunities:**

A Pre-dissertation Travel Grant (\$2,400), The Theodore N. Romanoff Prize (\$2,000), The William P. McHugh Memorial Fund grant (\$600), and Research Associate positions of 3-12 months (no funding).

# SWITZERLAND



## POSTDOC PROGRAM

The Branco Weiss Fellowship awards young researchers with a personal research grant, giving them the freedom to work on whatever topic they choose anywhere in the world, for up to five years. This research fellowship is designed to support postdoctoral researchers after their PhD and before their first faculty appointment. Those in current postdoctoral positions are also eligible. Ideally, fellows pursue unconventional projects in new areas of science, engineering and social sciences. The ideal applicant has the competencies to design a surprisingly novel and scientifically rigorous research project which blazes new trails, profiting from the freedom uniquely offered by the fellowship.

### You are Eligible if you:

- officially hold a PhD on January 15, 2017
- depart from the mainstream of research in your discipline
- have a record of outstanding scientific achievement
- demonstrate in the proposal a willingness to engage in a dialogue on relevant social, cultural, political or economic issues across the frontiers of your particular discipline

### To apply:

Please have the following documents (pdf files) ready for uploading:

- Letter of motivation positioning your research within your discipline and including a scientific vision explaining why your project differs from the mainstream (1 page max.)
- Your CV (4 pages max.)
- Your project proposal (4 pages max.) Please put the project abstract text also used for the online application at the beginning of the proposal.
- Copies of your three best publication
- Completed template Application Overview

Please have your project abstract text (1,500 characters maximum including spaces) ready when starting the application process.

Please note that letters of support do not have to be submitted upon application but will only be asked for once your application is taken further. Timelines and budgets are only required in case you are granted a fellowship.

To avoid server-overload, please submit your application at least 1 to 2 days before the deadline.

# A N A L Y Z E

### Funding:

Society in Science fellows can expect financial support for up to 5 years as well as the opportunity to work at any academic institution of their choice throughout the world. The fellows belong to a diverse, dedicated and intellectually stimulating group. They meet at least once a year to present and discuss their research projects to scientific and public audiences. The amount granted is CHF 100'000 per year (approximately \$98,360). It may be used to cover all legitimate cost of research (i.e. salary and/or equipment, travel cost, consumables, personnel etc.).

### Duration:

The 5 year fellowship is awarded in two installments:

1. The pioneer phase – first 2 years.
2. The exploitation phase – last 3 years.

At the end of the pioneer phase a review is conducted. This evaluates the project, its continued originality and the productivity of the fellow. The review is conducted in accordance with a list of requirements, communicated to fellows at the start of their research.

## JAPAN-UNITED STATES FRIENDSHIP COMMISSION

This residency program allows the artists to research and experience both the traditional and contemporary artistic milieu of Japan. Artists are free to live anywhere in the country to pursue activities of greatest relevance to their creative process. While many artists chose to remain in Tokyo, others live in Kyoto or other cities, and still others work in rural settings or travel around the countryside. The International House of Japan provides in-depth orientation materials, expert advice and professional contacts, as well as logistical support during the residency period.

The program, which remains a high priority for the Commission and the NEA, is highly competitive and attracts several hundred applications each year.

## Primary Eligibility:

- Candidates must be citizens or permanent residents of the United States.
- Candidates must live and work professionally primarily in the United States.
- Candidates must be professional creative artists (contemporary or traditional) working as: architects, choreographers, composers, creative writers, designers, media artists, playwrights, librettists, visual artists and solo theater artists who work with original material (including puppeteers, and performance artists).

## TEACHING ASSISTANT PROGRAM

The Teaching Assistant Program in France offers the opportunity to work in France for 7 months, teaching English to French students of all ages. Each year, over 1,100 American citizens and permanent residents teach in public schools across all regions of metropolitan France and in the overseas departments of French such as Guiana, Guadeloupe, Martinique and Réunion.

The Teaching Assistant Program in France (TAPIF) is a joint initiative of the French Ministry of Education, the Centre international d'études pédagogiques (CIEP) and the Cultural Services of the French Embassy. The program's goal is to strengthen English-language instruction in French schools by establishing a native speaker presence, while also providing American Francophiles with excellent teaching experience and first-hand knowledge of French language and culture. Candidates must be between 20-35 years of age.

Assistants teach 12 hours per week in up to 3 schools. Classes are conducted in English. Teaching assistants conduct all or part of a class, typically leading conversations in English. Duties include serving as a resource person in conversation groups, providing small group tutorials, and giving talks related to American studies. Assignments vary depending on the school's needs and the assistant's abilities.

**Contracts are available at elementary or secondary school level:**

- Elementary School – Children aged 8-11 years old. Assistant leads oral activities with small groups, or works alongside the teacher with the entire class present. Good level of French required.
- Secondary School – Students aged 11-18 years old. Assistant serves as a resource person in conversation groups, provides small group tutorials, facilitates English-language clubs, or works alongside the teacher with the entire class present. Proficient level of French required.

### Funding:

The monthly salary for teaching assistants comes to approximately €790 NET (approximately \$838), which in most cases (depending on personal spending habits), is enough to live a comfortable lifestyle in most regions of France. €790 per month allows most assistants to buy food, rent a room or apartment in their town, and live a modest student lifestyle.

## TERRA SUMMER RESIDENCY FELLOWSHIPS IN GIVERNY, FRANCE

The Terra Summer Residency brings together doctoral scholars of American Art and emerging artists worldwide for a nine-week residential program in the historic village of Giverny, France. The program encourages independent work while providing seminars and mentoring by senior scholars and artists to foster reflection and debate. The residency provides an opportunity for participants to widen their academic and creative horizons, explore international cultural perspectives, and forge exchanges and networks.

### **Applicants must be either:**

- A visual artist with a master's degree or its equivalent at the time of application. Preference is given to applicants who have completed their degree within the past five years.
- A doctoral candidate researching American art and visual culture or its role in a context of international artistic exchange prior to 1980. Candidates at all stages of doctoral research are welcome to apply.

Applicants must be nominated by their dissertation advisor or professor or previous art-school supervisor. Each professor may nominate a maximum of two candidates each year. (See the application form for full nomination and application procedures.) Applicants will be evaluated on intellectual and creative excellence, scholarly and artistic accomplishments, and ability to contribute in a collegial and interdisciplinary community. As the program's working language of the program is English; knowledge of French is an asset but not required.

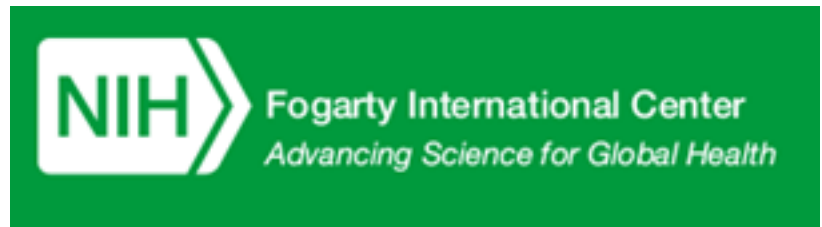

Fogarty's global health research and research training programs offer a variety of funding opportunities. Upcoming application deadlines, announcements from the NIH Office of Extramural Research, and various funding opportunities are listed in this website.

Two current funding opportunities:

### **Global Noncommunicable Diseases and Injury Across the**

**Lifespan:** Exploratory Research (R21) supports planning, design and initial pilots for locally relevant and catalytic research on non-communicable diseases (NCDs) or injury in low and middle-income countries (LMICs). Research addressing multiple NCDs and their risk factors and research addressing NCDs as comorbidities for/with infectious diseases including HIV/AIDS is encouraged. **Scientists in the United States (U.S.)** or upper middle income countries (UMICs) are eligible to partner with scientists in LMIC institutions. Income categories used are defined by the World Bank at <http://data.worldbank.org/about/country-classifications/country-and-lending-groups>. Pilot activities and research are expected to inform the development of more comprehensive research programs that contribute to the long-term goals of building sustainable research capacity in LMICs to address NCDs and injury throughout life and to lead to diagnostics, prevention, treatment and implementation strategies. The proposed work may also contribute to developing a base for research networking and evidence-based policy beyond the specific research project.

### **International Research Scientist Development Award (IRSDA)**

**(K01):** The purpose of the International Research Scientist Development Award (IRSDA) is to provide support and protected time (3-5 years) to **advanced postdoctoral U.S. research scientists and recently-appointed U.S. junior faculty** (applicants must be at least two years beyond conferral of doctoral degree) for an intensive, mentored research career development experience in a low- or middle-income country (LMIC), as defined by the World Bank leading to an independently-funded research career focused on global health. This Funding Opportunity Announcement (FOA) invites applications from early-career investigators from any health-related discipline who propose career development activities and a research project that is relevant to the health priorities of the LMIC under the mentorship of LMIC and U.S. mentors.

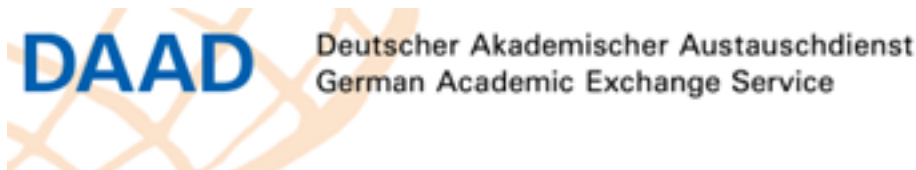

## AERONAUTICS, SPACE, TRANSPORTATION, AND ENERGY RESEARCH FELLOWSHIPS

DLR is Germany's national research center for aeronautics and space. Its extensive research and development work in Aeronautics, Space, Transportation and Energy is integrated into national and international cooperative ventures. Approximately 7,400 people are employed in DLR's 33 institutes and facilities at 16 locations in Germany.

This program is intended for highly-qualified foreign doctoral and postdoctoral students as well as senior scientists from the fields of Aeronautics, Space, Transportation, and Energy. DLR-DAAD Fellowships offer scientists and researchers the opportunity to conduct special research at the institutes of the DLR in Germany. Please note that within the DLR-DAAD program, you can apply only for a DLR institute, not for a university or any other institution.

DLR-DAAD Fellowships are awarded on an individual basis. Each Fellowship announcement will indicate the specific qualification requirements and terms of the visit. The host DLR Institute and the fellowship candidate will agree upon the length of stay.

At the time of their application, applicants for a DLR-DAAD Fellowship must be able to prove their outstanding study or research achievements, Doctoral Students must have completed their studies or research with a university degree in the last 6 years, Post Docs must have completed their studies with a doctorate/PhD in the last 2 years, and Senior Scientists must be working in higher education or at a research institute; positions are open to outstandingly-qualified academics and scientists who should hold a doctorate/ PhD and be assessed individually according to prerequisites, speak and write English; a knowledge of German is advantageous, and not be of German nationality.

The application procedure occurs online through the DAAD online portal. Then, an "Application summary" (pdf file), which is generated in the DAAD portal after the online application procedure has been completed, will need to be sent by email. Hardcopies of letters of recommendation need to be mailed to the application address by post.
